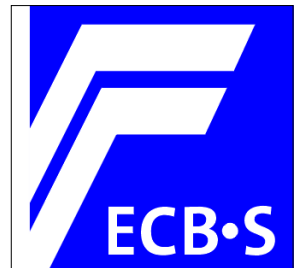

SCALE OF FEES

Certification procedure according to ISO/IEC 17065

1. Handling fees ¹⁾

1.1 Initial certification **100 % of the basic fee**

1.2 Technical modification / prolongation **60 % of the basic fee**

- if a practical technical follow-up test in the laboratory or
- examination of design/drawings and approval exclusively by ECB are required.

1.3 Technical modification / prolongation **30 % of the basic fee**

- without practical technical follow-up test in the laboratory if a report of a cooperation partner is available or
- examination and approval of design/drawings by the cooperation partner is available.

1.4 Deviation in an individual case

ECB reserves the right to invoice based on actual cost. In individual cases, up to 100 % of the basic fee may be invoiced in the cases described in 1.2 and 1.3 if extraordinarily high cost arose in connection with the evaluation and/or assessment.

1.5 Charges in the event of termination

In the event of premature termination for which ECB is not responsible, ECB reserves the right to invoice the services provided up to this point to the client. For that, a signed Application for Certification ECB•S C11 must be in place.

1.6 Advance payments

ECB is entitled to demand advance payments prior to or partial payments in accordance with the progress of the provision of services.

¹⁾ Essentially, the handling fee comprises the assessment of certifiability considering the basic requirements of certification as, e.g., the technical documentation, the test report and/or assessment report as well as specification of the contents of the certificate and its awarding. In the event of a technical modification/prolongation, the existing certifiability and the product monitoring carried out in the production plants are assessed. For the initial certification, in addition the administrative expenses for the provision of the certification data and the details of the applicant for addition to the certification data base, including publication, are included.
